

Procedure for verification of Distance from notified Forest, National park, Sanctuary & Eco Sensitive Zone

About the Service

Distance from notified Forest, National park, Sanctuary & Eco Sensitive Zone is a pre-requisite to apply for Consent to Establish (CTE) from the Jharkhand State Pollution Control Board.

Ownership of land is not required for application.

Documents Required

- Village map or Cadastral map in PDF format of scale 16"=1 mile depicting the proposed land clearly

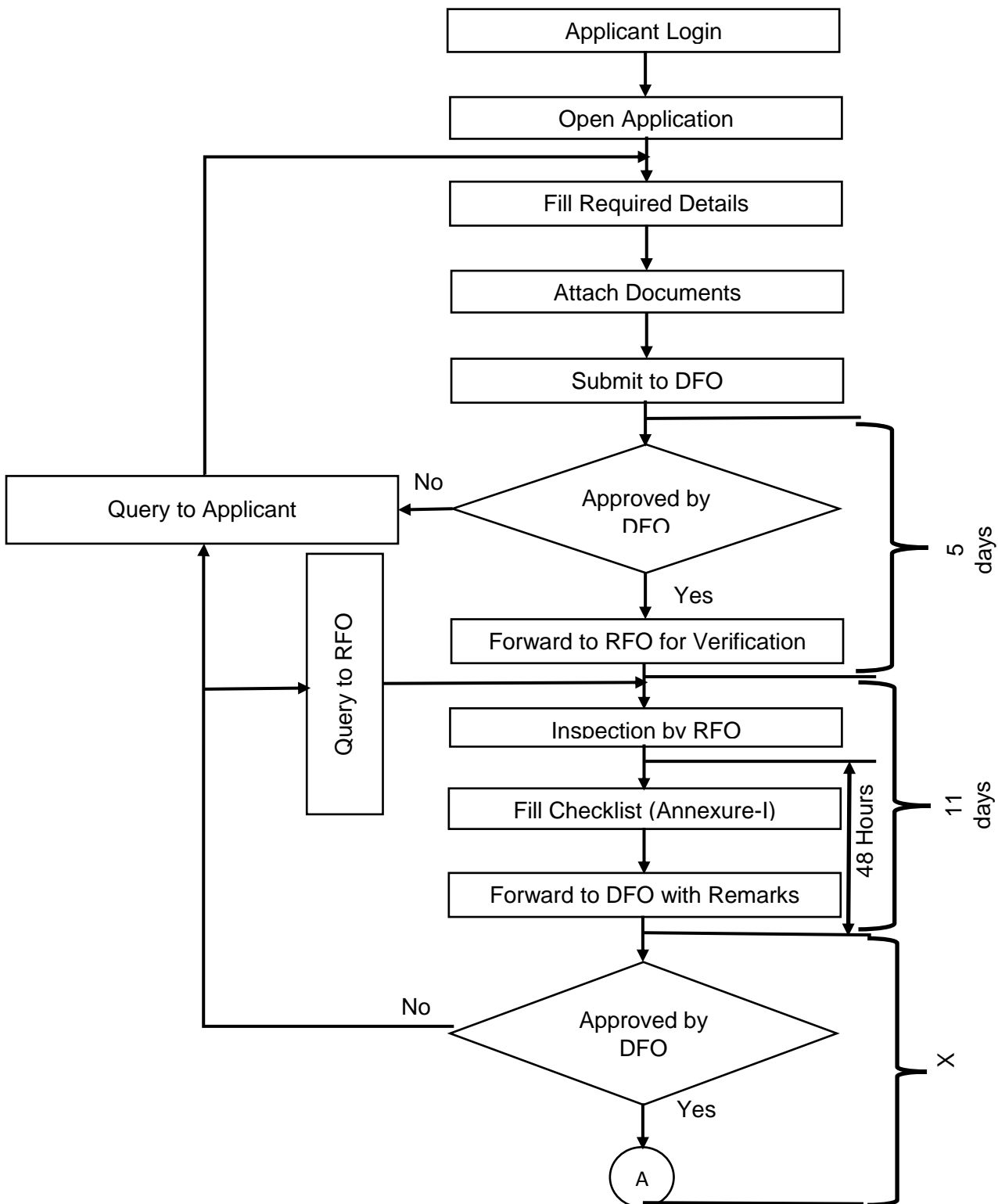

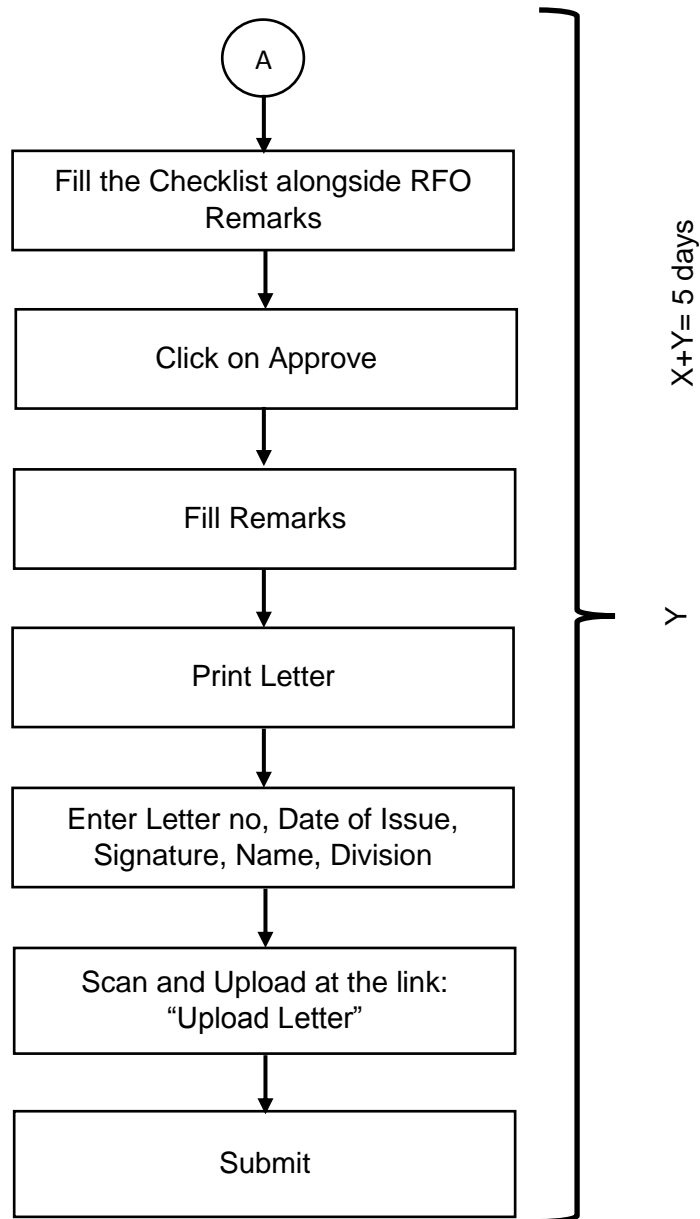


Process Flow
